- Wednesday, April 4, 2018 Publish NOTICE OF BUDGET COMMITTEE MEETING in a newspaper of general circulation in the district. This notice must give the District's website address where the notice is also posted for at least 10 days prior to the meeting. (Notice to be published not more than 30 days prior to the date of this meeting.) *ORS 294.426(5)(a) and (b)*
- Monday, April 9, 2018 REGULAR BOARD MEETING
- Thursday, April 19, 2018 ORGANIZATIONAL MEETING OF THE BUDGET COMMITTEE. Elect presiding officer. Budget committee may choose to elect an alternate presiding officer. Establish future meetings calendar.
- Monday, April 23, 2018 BOARD WORK SESSION (Location: Central Howell)
- Monday, May 7, 2018 REGULAR BOARD MEETING
- Thursday, May 10, 2018 BUDGET COMMITTEE MEETING. Presentation of the budget message by the executive officer and the budget document by the budget officer. Receive questions and comments from citizens. Announce the time and place of the next meeting, if any. Additional meetings not published in the original Budget Committee notice must be advertised as a meeting of the government body. *ORS 294.426* All meetings shall be open to the public. *ORS 294.406(2)* The Budget Committee may demand and receive any information it requests and compel the attendance of any employee at its meetings. *ORS 294.428(3)* The budget document is filed in the District Office as a public record, and a copy of the document or part thereof is made available to any person requesting it. A majority of the members of the Budget Committee is required to pass any motion and approve the budget document. *ORS 174.130*

Friday, May 25, 2018	Deadline to notify classified personnel of reasonable assurance of continued employment during the subsequent academic year. ORS 332.554
Wednesday, May 30, 2018	Publication of the NOTICE OF BUDGET HEARING, AND A SUMMARY OF THE APPROVED BUDGET (ED1) (not more than 30 days nor less than 5 days prior to hearing). ORS 294.448
Monday, June 11, 2018	REGULAR BOARD MEETING and PUBLIC HEARING ON THE BUDGET, as approved by the Budget Committee. Enact resolutions adopting the budget, making the appropriations and categorizing and declaring the tax levy. ORS 294.408 and ORS 294.456
Monday, June 25, 2018	BOARD WORK SESSION
